

“BRAVECTO® VET CLINIC SEEING DOUBLE PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. This promotion is a game of chance and prizes will be awarded by way of a random prize draw. There will be a total of two (2) prize draws conducted via a random draw from entrants that meet the entry criteria.

ELIGIBILITY

3. Entry is only open to Australian veterinary clinics (each an “**Eligible Clinic**”).
