
Nobilis® EDS



INACTIVATED VACCINE FOR LAYING HENS

ACTIVE CONSTITUENT: Inactivated EDS '76 virus strain BC14 inducing $\geq 6.5 \log_2 HI$ units per dose in an oil adjuvant emulsion



Inactivated vaccine for the protection of laying hens against Egg Drop Syndrome '76.

NOBILIS® EDS contains one immunogenic strain of EDS '76 virus. The virus has been grown on embryonated eggs and is inactivated with formalin. Subsequently it has been suspended in the aqueous phase of an oil adjuvant emulsion.

INDICATION:

The vaccine is recommended for protection against Egg Drop Syndrome '76.

DIRECTIONS FOR USE:

Recommended Vaccination Program

NOBILIS® EDS should be given to birds approximately 16-20 weeks of age but not less than 4 weeks before the expected onset of lay. Vaccinate healthy birds only.

DOSAGE AND ADMINISTRATION: SHAKE THE BOTTLE WELL BEFORE USE.

Before using vaccine allow it to reach ambient temperature (15°C-25°C). Each bird should be given 0.5 mL of vaccine intramuscularly in the thigh or chest muscle or subcutaneously into the lower part of the neck. Use the entire contents when first opened. Use sterile injection equipment. Do not mix with other vaccines.

IMMUNITY

If vaccination has been carried out correctly the birds will develop antibodies at a level which provides protection against Egg Drop Syndrome '76.

VACCINATION REACTIONS

In healthy birds no clinical reaction to vaccination will be observed. For some weeks after vaccination a slight swelling may be felt at the site of vaccination. Local tissue reactions may occur.

WITHHOLDING PERIOD: NIL

ADDITIONAL SAFETY INFORMATION

The vaccine is harmless but the adjuvant is potentially irritant if administered by injection to humans. Much depends on the amount injected.

Should a vaccinator by accident inject himself or a bystander, a local reaction may occur. It is recommended that the advice of a doctor is sought, taking care to inform the doctor that the vaccine is in oil emulsion and to take this leaflet or a Material Safety Data Sheet to the doctor.

FIRST AID:

If poisoning occurs, contact a doctor or Poisons Information Centre. Phone Australia 131126.

Dispose of empty container by wrapping with paper and putting in garbage. Discarded needles/sharps should be placed in a designated and appropriately labelled "sharps" container.

Store between 2°C and 8°C (Refrigerate. Do not freeze.) Broached vials should be used within 3 hours.
